RCA and Korea

- **Korea's Joining in RCA as a MS : 1974**
 - Korea participated in the 1st RCA Representatives Meeting (now GCM) in 1973 in Vienna as an observer
- **National RCA Representatives**
 - 1974-1985 KAERI (RCA under DDG-RI)
 - 1985- Present MOST (RCA under DDG-TC)
- **Present National RCA Representative:**
 - Director, Atomic Energy Cooperation Division
Ministry of Science and Technology

Chronology of NRM in Korea

- 8th RCA Working Group Meeting (WGM) in 1986 in Seoul
- 24th Meeting of National RCA Representatives (NRM) in 2002 in Seoul and Daejeon

RCA Events hosted in Korea

- 2002 : RCA 7 events (Non-RCA 8 events)
- 2003 : RCA 14 events (Non-RCA 5 events)
 - SARS impact
- 2004 : RCA 5 events (Non-RCA 2 events)
- 2005 : RCA 6 events planned,
Non-RCA 7 planned

Government's Study Projects

- **Research Contract between MOST and KAERI on Effective Participation in RCA Program**
 - Nuclear Policy Research Team and International Cooperation Office at KAERI
 - Survey on RCA activities
 - Study on effective participation in RCA projects
 - US\$ 30,000-50,000 per contract
(Including logistic support for RCA events hosted in Korea)

Current Contributions to RCA

- **Lead Country for RCA Thematic Sectors in Energy Planning and Research Reactor Utilization since 1999**
 - Also PLC for Low-level Radioactive Waste Management during 1998-2000
- **RRU**
 - To provide hosting for trainings on isotopic analysis and hydrological data interpretation: Geo-environmental Sciences Section, KAERI
- **Hosting RCARO**
 - To fully provide operational budget

Hosting of RCARO

- Korea offered hosting of RCARO in 2000 at 22nd NRM in Mumbai.
- RCARO opened in March 2002 in Daejeon in celebrating 30th Anniversary of RCA Agreement.
- In March 2005, RCARO went into full operation after 3 years of interim operation.
(Appointment of a new Director, RCARO)

Purpose of Hosting of RCARO

- To demonstrate Korea's strong intention to contribute to the RCA MS's and the region
- To support IAEA in its technical cooperation endeavors
 - From recipient country to donor country
- To exhibit Korea's firm belief that nuclear technology can contribute achieving development goals in the region

Operational Aspects

- **RCARO Steering Committee** : To give advice and make decisions on major operational and management issues of RCARO on behalf of the host country
 - Chair : Director General, Atomic Energy Bureau, MOST
 - Members : 11 Experts including Director of RCARO
- **Financial Support for RCARO Operation**
 - US\$ 0.4M ('02) → 0.48M ('03) → 0.57M ('04) → 0.68M ('05)

Some Comments by MS's

- **Salary of the Director when Director is not a Korean national**
 - No change in its policy
 - Director's salary from originating country is considered as the country's contribution to RCA and RCARO.

Some Comments by MS's (cont'd)

- **Qualifications and selection process of the Director candidates**
 - Selection Committee was composed by Advisory Committee.
 - Selection criteria and qualifications approved at 27th NRM

Some Comments by MS's (cont'd)

- **RCARO staff need not be from Korea**
 - According to the current Working Paper that was adopted by Member States, RCARO Director is responsible for hiring RCARO staff locally.
 - However, MOST encourages temp recruitment of RCARO staff from Member States. Cost-free experts would be most welcomed.

Some Comments by MS's (cont'd)

- **Composition of RCARO Advisory Committee**
 - 27th NRM in Malaysia composed RCARO Standing Advisory Committee.
 - All Member States have right to address on RCARO matters.

Some Comments by MS's (cont'd)

- **Possible influence on the operation of RCARO by Korean government**
 - Korean government, through the RCARO Steering Committee, reviews and provides advice mainly on operational budget of RCARO.
 - Daily operation of RCARO is autonomous.

Some Comments by MS's (cont'd)

- **RCARO only initiated projects related with Korea.**
 - Due to fund sources
 - Projects initiated by RCARO can be considered as a model or a pilot scheme towards the future partnerships. Experience with Korean fund sources would be good lessons when seeking other fund sources in the future.
 - Try to seek additional fund sources from other MS's and/or international organizations, which is one of the missions of RCARO.

For Better RCARO Operation

- **MS's should recognize RCARO as its own organization.**
 - No more Koreans
 - MS's support for RCARO to represent RCA in the future
- **Ms's active participation in RCARO activities and contribution to RCARO**
 - Sharing of operational fund of RCARO
 - Dispatch of MS's CFE to RCARO

For Better RCARO Operation (cont'd)

- **Korea's full support for operation of RCARO**

- Continue to support operational fund

When RCARO is an international level organization, it would be much efficient for Korean government to support with optimum process.

- **Korea takes a leading role so that RCARO will be an international organization.**

- Continue negotiation with Foreign Ministry of Korea for RCARO to function in Korea as an international level organization

Future RCARO

- **RCARO as RCA secretariat.**
 - Center of RCA activities
 - Need a road map for the future RCARO made by MS's
- **RCARO's legal basis in RCA.**
 - Necessary back-up measures by the MS and IAEA such as Amendment of RCA Agreement
