

# Guidelines for Selection of Experts of the Government Parties Participating in the RCA Promotion Activities

#### **Background**

With the aim of increasing the awareness of the RCA, RCARO has provided financial support to experts of the RCA Government Parties for their RCA promotional activities, taking advantage of their attendance at international or regional events.

# **Selection Criteria**

The following criteria will be taken into consideration for selection of appropriate experts:

- a) Opportunities to promote RCA activities to the audience by any means possible such as lectures, presentations and exhibitions
- b) The relevance to nuclear technology or the application of nuclear technology
- c) The relevance to RCA vision and mission
- d) The relevance to the thematic areas of RCA projects such as agriculture, environment, industrial application and human health
- e) The expected impact on decision makers in the Government Parties
- f) Opportunities to let the audience to understand the importance of application of nuclear technology in improving quality of life and regional/international cooperation as a means for that purpose
- g) Opportunities to increase RCA's partnership with regional/international organizations
- h) Efficiency of financial support from the RCARO considering cost effectiveness
- i) Equal opportunities amongst Government Parties
- j) Composition of audiences (a mixture of presentations to different audiences could provide greatest impact.)

#### **Qualification of Experts**

The selectee is required to have the following two qualifications:

a) The selectee shall be an expert who has technical expertise and more than 5 years of experience in nuclear science and technology and its application.

b) The selectee shall have experience in participating in the RCA projects.

### **Eligible International/Regional Conferences**

The conferences shall be held <u>from September 2015 to August 2016</u> and related to the following:

- a) Nuclear science and technology and its application
- b) Thematic areas of RCA projects such as agriculture, environment, industry and human health
- c) Opportunities to increase partnerships with the RCA

#### **Nomination Procedure**

Nominations should be submitted to the RCARO <u>by 19 July 2015</u> using the Nomination Form, given in attachment 2. Completed forms should be endorsed by the respective National RCA Representative and submitted to the RCARO.

#### **Selection Process**

Upon the call for applications by the RCARO, the Government Parties nominate appropriate experts for the programme. Based on the criteria and requirements of this guideline, RCARO selects appropriate applicants, informs the list of selected applicants to the SAC for their comments and finalises the selectees.

#### **Administrative and Financial Arrangements**

<u>Maximum 5 selectees</u> will be supported through the programme for the <u>period from September 2015</u> to August 2016.

Nominating Government Parties will be informed of the names of the candidates who have been selected and will be given full details on the procedures to be followed with regard to administrative and financial matters.

Selected experts will be provided with the following expenses for their participation upon request of the applicants:

- a) A round trip economy class airfare;
- b) DSA and Terminal Expenses on UN basis and
- c) Registration fee

# **Obligation of the Selectee**

The selectee should report the activities undertaken and outcomes of their participation, using the Participation Report Form given in attachment 3.
