# Terms of Reference

---

- Reviewed Terms of Reference
  - Updated document in tracked change
    - Provided in NRM pack
  - Minor changes only

Requested NRM action:

The Drafting WG recommends that the 43<sup>rd</sup> NRM **endorse** the Terms of Reference for the Drafting WG.

# Review of Regional Programme Framework

---

- Reviewed Regional Programme Framework (RPF) developed by PAC
  - RPF was under development at the time
- WG noted utility of the RPF for helping to develop the 2024-2029 MTS, but noted the possibility to include “big picture”, multi-disciplinary topics in the MTS such as:
  - Climate change
  - Zoonotic diseases
  - Cancer
  - Micro-plastics
  - Food security
- No specific action for NRM

# Review of 2018-2023 MTS

---

- Conducted a broad, framework analysis review of the 2018-2023 MTS to determine utility and broad changes required for 2024-2029
  - Analysis provided in NRM pack
- Major points include:
  - Draw from findings of 2018-2023 Mid Term Review
  - Importance of HR development
  - Note the unique characteristics (e.g. population, infrastructure) and regional needs of RCA
  - Note the disruptive impact of COVID and use of responsive technologies
  - Describe interaction with RPF
  - Increase focus on outcomes and impacts
  - Resource mobilisation may need expansion

# Review of 2018-2023 MTS (cont.)

---

Requested NRM action:

The Drafting WG recommends that the 43<sup>rd</sup> NRM **note** the framework analysis conducted on the 2018-2023 MTS, and **provide comments** to the Drafting WG Chair within one week after the NRM.

# Work Plan

---

- Developed a Work Plan for delivery of 2024-2029 MTS
  - Work Plan provided in NRM pack
- Factors considered:
  - International travel may not be feasible for some time - utilise frequent virtual meetings
  - **Input from NRs absolutely vital**
    - Multiple drafts with points for NR review and input included
    - Final MTS to be approved at 2023 NRM
  - Work plan will be a living document
