# 2005-2006 RCA Programme Preparation Schedule

- 2002 Oct.: Submission of Preliminary Proposals
- 2003 May: 25<sup>th</sup> Nat. RCA Rep. Meeting
- 2003 August: Lead Country Coordinators Meeting  
(The need to convene the meeting)
- 2003 September: 32<sup>nd</sup> RCA General Conference
- 2003 Dec: Dead line for submission of Project Requests
- 2004 Jan: Appraisal by the Agency



# Preliminary Proposals Received

●Agriculture :	20 proposals
●Health :	11 proposals
●Environment:	5 proposals
●Industry:	1 proposal
●En.and Res. React.:	4 proposals
●Rad. Waste Man.:	2 proposals
●Radiation Protection:	2 proposals



## **Lead Country Coordinators Roles**

- **In consultation with MSs:**
  - **Gather proposals**
  - **Tentative prioritization of the proposals under its sector**
  - **Submit proposals with the support of at least 3 RCA MS**
  - **May request Agency support for further refinements etc**

## **Lead Country Coordinators Roles (contd.)**

- **Submit preliminary budgets to the LCCs Meeting**
- **Proposals consider by Nat. RCA Rep. at Mar./April Meeting and at RCA GC**
- **National RCA Representatives Meeting decides**  
*(the proposal should have been circulated to the MSs one month before the meeting)*
- **Submit full proposals to the Agency by the end of 2003.**



# National RCA Representatives Meetings and LCC Meeting

- 25<sup>th</sup> Nat. RCA Rep. Meeting
- LCCs Meeting
- 32<sup>nd</sup> RCA GC
- Consider Preliminary proposals submitted by LCCs
- Discuss, prioritised and establish preliminary budget
- Endorse Proposals for submission to the Agency.



## **Self-Reliance and Sustainability**

- ◆ **Review countries and institutions that are ready to move towards self-reliance.**
- ◆ **Consider additional elements to strengthens capacity of institutions to use nuclear technologies to become more technically and financially self-reliant.**
- ◆ **Lead to sustainability.**



# Agreed Distribution of Hardcore

- **Agriculture** **25%**
- **Health** **20%**
- **Industry, Natural Resources** **35%**
- **Energy and Research Reactor** **10%**
- **Radiation Protection** **10%**

# Other Points for Considerations

- **To reduce the number of projects;**
- **Review projects proposed for extensions and continuation;**
- **National projects average fewer than five per country;**
- **Duration of projects could last longer than 2 years;**



## **Other Points for Considerations** (contd.)

- **Focus on regional needs;**
- **Prioritise proposals;**
- **Emphasis on results-based programming;**
- **Top down approach;**
- **Prepare thorough project document.**
