Ministerial Conference

- VIE updated the action plan on the hosting of the RCA Ministerial Conference in Vienna, Austria, on the occasion of the 51st RCA GCM and 66th IAEA General Conference in September 2022.
- One-day Ministerial Meeting and the 50th RCA Anniversary Ceremony will be held on the first day of the IAEA General Conference week in September 2022.
- Presentation from VIE containing the updated work plan, tentative agenda, roles and responsibilities, as well as the cost estimation for Ministerial Conference was uploaded for NRs consideration and approval.



Draft Ministerial Declaration

- After 43rd NRM, the draft declaration was circulated for NRs' consideration.
- Vietnam, as the host country of the Ministerial Conference and Chair of year 2022, agreed to consolidate the comments on the first draft and made a revision.
- In this connection, Vietnam requests if more support could be provided by GPs in the finalization of the draft Ministerial Declaration.
- The STF have submitted the latest version of the draft Ministerial Declaration to the 50th RCA GCM for NRs consideration.



RCA Exhibition and Other Activities

- Work plan and cost estimation for RCA Exhibition and Other Activities were submitted to the 50th GCM for NRs' approval.
- ROK would contribute a total of 170,000 USD including 100,000 to be sent directly to RCARO for the preparation of the RCA Exhibition and other activities, and maximum of 70,000 USD to the IAEA for the preparation of RCA Ministerial Conference.



Other Updates

- EBT contribution from other GPs are still welcome.
- Letters from RCA Chair to the Permanent Missions of RCA GPs is now being prepared and will be sent to the IAEA for distribution within next week.



Publication

- The STF agreed that only one publication for the 50th RCA Anniversary should be developed to avoid duplication and to provide comprehensive information.
- This anniversary publication will be the integration of information of the History of RCA, Success Stories, and the Results from Socio Economic Impact Assessments. In this regard, JPN has made a draft table of content of the publication for NRs consideration.
- There was also a suggestion that a salient or success story under the RCA programme submitted by NRs be included in this publication as well.





RCA Awards

- Further discussion about the set-up of committee, as well as the category and criteria of the Award should be made.



Recommendations

1. It is recommended that NRs approve the updated work plan, tentative agenda, roles and responsibilities, as well as the cost estimation and action plan of **the RCA Ministerial Conference**.
2. It is recommended that GPs review the latest version of the Ministerial Declaration and provide comments/recommendations to STF Chair within three weeks after the conclusion of the 50th RCA GCM.
3. It is recommended that NRs approve the work plan, cost estimation and the roles and responsibilities of **the RCA Exhibition and Other Activities**.
4. It is recommended that NRs review the draft table of content and work plan of the publication for the 50th RCA Anniversary.
