HRD (Performance Indicators 3.2)

Criteria 1 – Recipient GPs identify workforce requirements

Result: Not evaluated in the baseline review due to lack of data

- **Possible recommendations to to the MTS WG**
 - Recommend NRs to have projects progress review and update on the list of NPC, ANPC, and NPT on RCARO
 - Recommend NRs not to endorse participation in projects unless GPs clearly identify NPC, ANPC, and NPT on RCARO
- **Possible updates to the baselines for Final Review :**
 - RCARO/ PAC database (based on project report, if any)
 - Data that has been collected by RCARO/PAC from previous questionnaires (during developing RPF)
 - *Establish simple questionnaire on HRD (asking on the workforce requirements)*

Criteria 2 – RTC participants are from NPTs

Result: Not evaluated in the baseline review due to lack of data

- **Possible recommendations to the MTS WG :**
 - RCA Chair call reminding NRs to only nominate NPT members for RTCs
 - NRs only nominate participants from NPTs
- **Possible updates to the baselines for Final Review :**
 - Review database on the list of RTC participants
 - Secretariat to consider implementing rules/criteria whereby only NPT members can be nominated for RTCs
 - *Establish questionnaires for FR (asking on the number NPT Members)*

Criteria 3 – Knowledge is shared with NPT after RTCs

Result: Not evaluated in the baseline review due to lack of data

- **Possible recommendations to the MTS WG:**
 - Very hard to measure. Suggest removing.
(This indicator is good to evaluate the benefits of the RTC)
- **Possible updates to the baselines for FR :**
 - Establish online questionnaire (asking on the action taken after RTC implementation / effectiveness of the RTC to GPs)

Suggestion from PAC

- PI 3.2 was not evaluated due to lack of data. Information related to these items should be reported by NPCs in their reports to LCCs and the LCCs should present a summary in their reports to the NRM. (IAEA PPARs do not cover these aspects). **PAC has prepared a revised guideline for development, implementation and monitoring of RCA Projects, which cover these aspects.**

Suggestion from PAC

- Implementation of recommendation to 40th NRM WG on HRD
 - Duration of RTCs (two weeks instead of one)
 - Assessment of knowledge of participants at the beginning and end of the RTCs
 - Maintaining the repository of training material used in RTCs
 - Group fellowship training with the support of regional universities
