Lessons learned	Early planning of procurement is necessary; not enough time was allowed for in the project for planning procurement in order to meet IAEA deadlines. The Virtual format for the First Coordination (Kick-Off) Meeting worked well and should be considered, even in non-pandemic circumstances. However, large virtual meetings function best when the participants already know each other, so they may be less suitable for kick-off meetings.
